Equity Funding Distribution Model



History / Purpose

The Victim Services Partnership was collectively established by seven victim serving organizations within the footprint of Greater Green Bay Community Foundation (GGBCF) to address deep cuts in Victims of Crime Act (VOCA) Funding. With Wisconsin's annual funding expected to go from \$44.5M to roughly \$13M, our community is on a trajectory to lose up to \$2.8M each year over the next three years. These organizations are collaborating in co-advocacy efforts to educate and engage the community in the survival of these critical local services.

Fundraising Goal

Our goal is to raise \$3M in 3 years. We collectively agreed that 99% of the funds raised each month will be distributed according to an equity focused distribution model inspired by Weaving Ways.



Organizations Eligible for Funding

For the first three years of this collaborative fundraising effort, eligibility of distributed funds is limited to the initial collaborative members including:

- Family Services of Northeast WI
- Golden House
- Rainbow House
- Violence Intervention Project
